Overview & Current Events

Canadian Natural Resources is an energy company that operates in the acquisition, exploration, development, production, marketing, and sale of crude oil, natural gas liquids (NGLs), and natural gas. The company is headquartered in Calgary, Alberta. Canadian Natural Resources common stock is cross-listed on the Toronto Stock Exchange and the New York Stock Exchange, where it trades with a market capitalization of US\$33 billion. In this report, all figures referenced are in Canadian dollars and the TSX-listed shares have been used for the purpose of valuation analysis.

In early March, Canadian Natural Resources reported (3/7/19) financial results for the fourth quarter of fiscal 2018. During the quarter, the price of Canadian crude collapsed even more than the price of WTI. Consequently, the company posted losses of \$0.21 per share, much worse than the expected profit of \$0.14 per share. However, in early December, Alberta enforced production cuts to alleviate the supply glut. As a result, the discount of WCS to WTI has shrunk from about \$39 to \$12 in the first quarter. This development will certainly improve the results of the company in the upcoming quarters. In 2018, the company grew its production by 12% to a record level of 1.08 million barrels per day while it also reduced its operating costs to an all-time low of \$21.05 per barrel. Moreover, the oil producer grew its proved reserves by 12% in the year and thus it now has 27.7 years of reserves.

As Canadian Natural Resources is an almost pure upstream company, its financial performance has been extremely volatile over the last decade. Given its high sensitivity to commodity prices, it is nearly impossible to make accurate forecasts. With that said, we believe the company's performance is likely to improve considerably moving forward, primarily due to higher prices of oil and natural gas. Moreover, management expects to grow production by 7.5% per year on average until 2022. Therefore, we expect earnings-per-share to rebound to about \$4.00 by 2024.

Canadian Natural Resources has compounded its per-share dividend at more than 18% per year over the last decade. Due to its high payout ratio this year, we expect dividend growth to somewhat decelerate in the upcoming years.

Canadian Natural Resources has traded at an average P/E ratio of 15.5 over the last decade if we exclude the 2015 – 2017 period, in which the company's valuation was not meaningful due to depressed earnings. If the company achieves our anticipated earnings-per-share of \$4.00 by 2024, we expect the stock to trade around 13 times its annual earnings in that year. As a result, the stock will incur an 11.5% annualized drag due to contraction of its valuation level.

Safety, Quality, Competitive Advantage, & Recession Resiliency

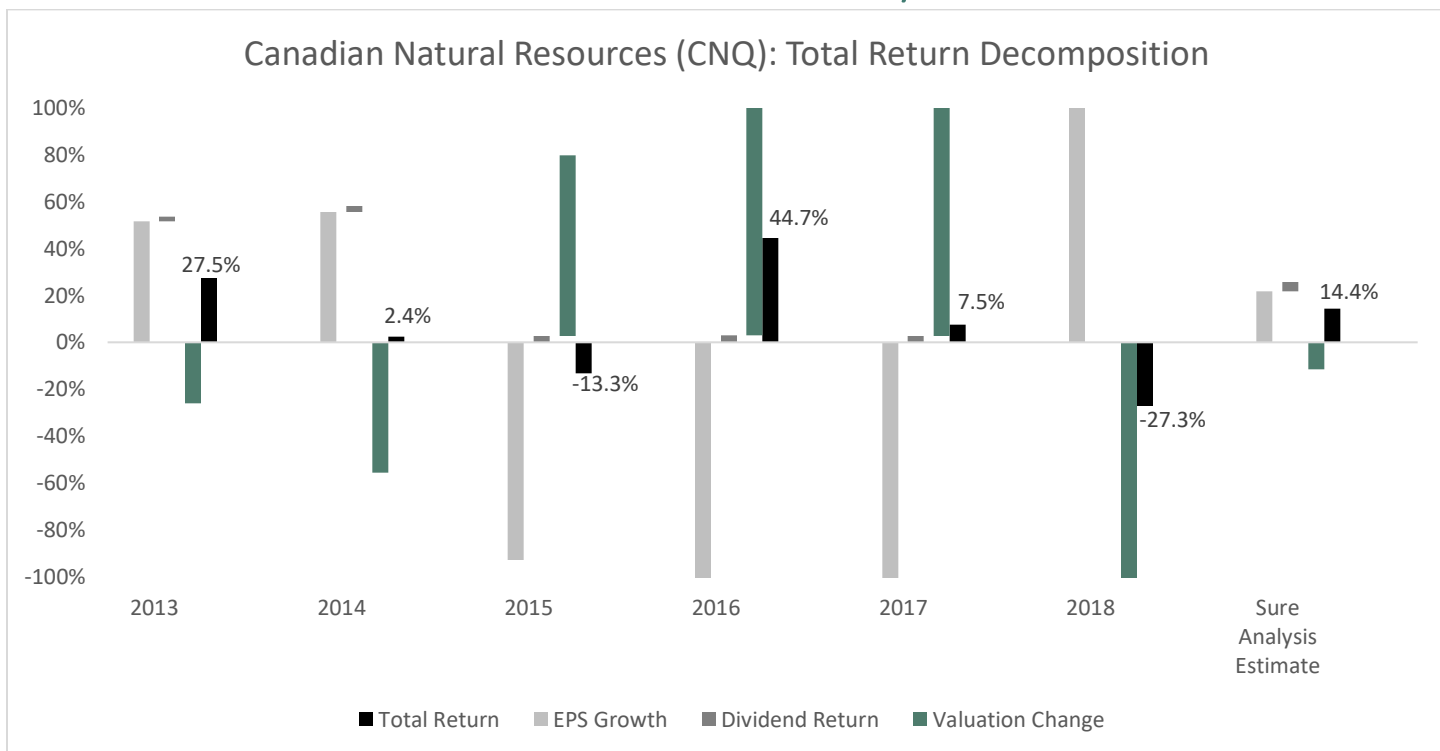

The competitive advantage of Canadian Natural Resources is the high quality of its assets, which have a long life and low decline rates. However, due to the almost pure upstream nature of its business, the company is greatly affected by the price of oil and natural gas. This is evident from its depressed earnings during the period of low commodity prices in 2015 - 2017. Moreover, the standard deviation of the stock is far higher than the average stock in our investment universe. Volatility-averse investors should take note of this before considering a position in this security.

Final Thoughts & Recommendation

Canadian Natural Resources was severely affected by the collapse of the price of Canadian crude in the fourth quarter. However, thanks to high production growth and an expected rise in oil prices, the stock can offer a 14.4% average annual return over the next five years. As a result, it earns a buy recommendation from Sure Dividend at current prices, particularly for investors who expect higher prices of oil and natural gas in the upcoming years. On the other hand, investors should note the high sensitivity of the stock to commodity prices and its huge downside risk in the event of a recession or a plunge of the prices of oil and natural gas.
