Overview & Current Events

Donaldson has been creating filtration solutions for a wide array of applications since 1915. Its sales consist of filters in various engine and industrial applications as core categories, but continuous innovation and acquisitions have expanded the portfolio. It is expected to produce about \$3 billion in revenue this year and sports a current market capitalization of \$6.2 billion.

Donaldson reported Q2 earnings on 3/6/19 and results were strong, setting a record for second quarter revenue and earnings-per-share. However, the company's guidance for fiscal 2019 was slightly reduced, and the stock declined meaningfully as a result.

Total sales were up 5.9% in Q2 as a variety of factors contributed to the increase. The acquisition of BOFA International added 1.4% to the top line, while currency volatility decremented sales by a rather sizable 2.7%. Strong pricing, however, helped add 1.3% to the top line, and organic increases made up the balance. Donaldson mentioned in the earnings release that volatility, particularly in December, hurt Q2 results, but it was still a record for the company.

Operating margins were flat compared to last year at 12.1% of revenue. Gross margins were 0.9% lower year-over-year as the company experienced headwinds from higher raw material and supply chain costs, partially offset by strong pricing. However, lower operating expenses, which fell from 20.9% of revenue to 19.9%, helped offset the weakness in gross margins.

In total, adjusted earnings-per-share were up 9.3%, rising from 43 cents in the year-ago period to 47 cents in this year's Q2. The company now expects full-year earnings-per-share of \$2.27 to \$2.41 on sales growth between 5% and 9%. The slight reduction against Q1's guidance is due to elevated currency headwinds, and not operational deterioration. While we acknowledge the reduced guidance because of currency headwinds, our estimate remains unchanged for this year at \$2.36 per share.

Donaldson's earnings growth has been inconsistent in the past decade as it is very much beholden to economic conditions around the world. Its customer base is diverse and deep, but growth seems to come in bunches, not in a linear fashion. Looking forward, we are forecasting robust 10% earnings-per-share growth annually, with ~18% growth forecast for 2019.

The company will achieve these results through a variety of methods. First, sales increases ought to continue from organic growth, pricing increases, and acquisitions, which should amount to mid-single digits or better growth. Margins should at least remain flat in the coming years as pricing increases and cost savings look to offset rising raw material costs, as they did in Q2. Lastly, Donaldson is buying back stock each year, good for ~2% annually. We forecast moderate

dividend growth, but Donaldson is not an income stock, choosing instead to use its excess cash for acquisitions and share repurchases.

Valuation Analysis

Donaldson's price-to-earnings multiple has been remarkably steady in the past decade and given where it is today, we are forecasting just a 1.1% tailwind to total returns from the valuation as shares are slightly under fair value.

We are forecasting the yield to be roughly flat to where it is today as future dividend growth should roughly match earnings and share price growth. This is not a stock one buys for the current yield or dividend growth, as the company's stated strategy requires the use of excess cash for acquisitions and buybacks.

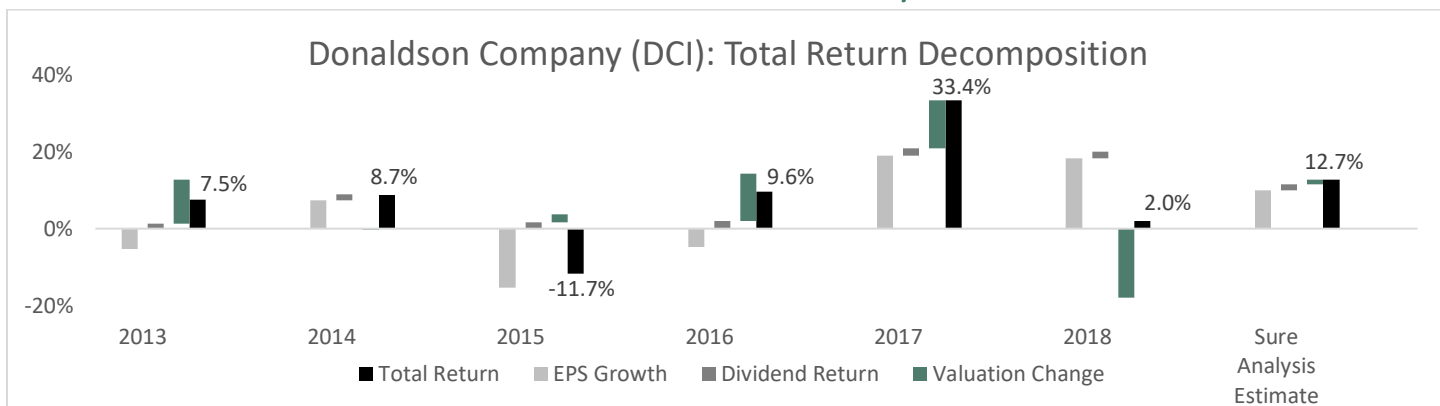
Donaldson's payout ratio remains around 30% of earnings and we expect that is where it will stay for the foreseeable future. As mentioned, Donaldson prefers to use most of its excess cash for acquisitions and a small amount of share repurchases, but it does raise the dividend regularly.

Donaldson's recession performance is somewhat of an issue, as you'd expect for an industrial stock, and earnings will likely fall significantly during the next downturn. It does enjoy the competitive advantage of more than 100 years of experience in its field, as well as a strong history of innovation and a sizable installed customer base.

Final Thoughts & Recommendation

Overall, Donaldson looks attractive. The stock is slightly undervalued and growth moving forward should be a vast improvement over the past few years. We are forecasting total annual returns of 12.7%, consisting of the current 1.6% yield, a 1.1% tailwind from the valuation, and 10% from earnings growth. Donaldson looks poised to deliver strong returns to shareholders and thus, it looks appropriate for investors seeking growth in the industrial sector. Donaldson is not an income stock and likely never will be, so it would be inappropriate for those seeking current yield. However, strong growth forecasts make Donaldson attractive for growth-oriented investors looking for exposure to industrials. Overall, the stock earns a buy recommendation from Sure Dividend at current prices.
