Overview & Current Events

United Parcel Service, founded in 1907 and headquartered in Atlanta, GA, is a logistics and package delivery company that offers services including transportation, distribution, ground freight, ocean freight, insurance and financing. Its operations are split into three segments: US Domestic Package, International Package, and Supply Chain & Freight. UPS trades with a market capitalization of \$100 billion.

On July 24th, 2019 UPS reported Q2 2019 results for the period ending June 30th, 2019. For the quarter the company generated revenue of \$18.05 billion, representing a 3.4% increase compared to Q2 2018, driven by gains in average daily volume in the U.S. and higher-quality, currency-neutral revenue in the International segment. The U.S. Domestic segment grew revenue by 7.7%, which was offset by 2.7% and 3.1% respective declines in the International and Supply Chain & Freight segments. Reported net income came in at \$1.69 billion compared to \$1.49 billion in the year ago period, while adjusted earnings-per-share equaled \$1.96 versus \$1.94 previously.

UPS also updated its 2019 outlook. For the year the company anticipates adjusted free cash flow to be in the \$3.5 billion to \$4 billion range, an effective tax rate between 22% and 24% and adjusted earnings are expected to be in the \$7.45 to \$7.75 range (unchanged from previous guidance).

Growth on a Per-Share Basis

During the last financial crisis, UPS' profitability declined substantially. Earnings-per-share dropped from \$4.11 in 2007 to \$2.31 in 2009. Since then profits have risen relatively consistently. When we look at the 2007-2018 timeframe, earnings-per-share grew by 5.3% annually. The growth rate since 2010 has been 9.3% per annum.

Profit growth during 2018 was higher than in recent years, which is due to the positive one-time impact of a tax rate decline due to tax legislation changes in late 2017. Even without that impact the growth rate would have been solid, though, as UPS benefits from macro tailwinds and is performing well operationally. One such tailwind is e-commerce, which leads to growth in the number of packages that have to be transported across the country. The strong economy drives demand for UPS' services by businesses as well as by consumers, which increase their spending due to higher disposable incomes. With online shopping growth continuing to outpace brick-and-mortar growth in the foreseeable future, UPS should continue to benefit from strong demand for its services.

Collectively, we believe UPS can grow by 6% annually over the intermediate-term. However, 2019 may not be as robust, given management's guidance of 2.9% to 7.0% anticipated improvement.

Over the past decade shares of UPS have traded with an average P/E ratio between 18 and 19 times earnings. While we believe a moderate premium is warranted for the quality of the business, we are more comfortable with 17 times earnings as a starting fair value baseline. Still, with shares trading near 15 times today, this implies the potential for a small valuation tailwind.

Safety, Quality, Competitive Advantage, & Recession Resiliency



United Parcel Service did not cut its dividend during the last financial crisis, but its payout ratio rose to a relatively high level due to the decline in the company's net profits. Since then, the payout ratio has stabilized around 50%, which appears highly sustainable. We believe that a dividend cut is unlikely, although not impossible during a steep recession.

UPS is the largest logistics/package delivery company in the US. Its top peers include FedEx, DHL Express, and the United States Postal Service. The macro environment is beneficial for the whole industry, thanks to the megatrend of online shopping, as well as a strong economy. None of the big players have an interest in a price war, so volumes could continue to rise even if base pricing is increased over time. Competitive pressures should therefore remain muted for the foreseeable future. UPS was impacted significantly during the last financial crisis, but it remained profitable.

Final Thoughts & Recommendation

Shares are up 13% since our last update, while earnings expectations remain unchanged for this year. United Parcel Service is one of the key companies in an industry that benefits from the online shopping megatrend. The business-tobusiness segment is doing well, too, and it seems likely that UPS will be able to grow its earnings-per-share at a solid pace during the next couple of years. Total return potential comes in at 11.7% per annum, consisting of 6% growth, a 3.3% dividend yield and the potential for a 2.4% valuation tailwind. We continue rate shares as a buy at the current quotation, although we are becoming less enthused as the valuation inches upward.
