Overview & Current Events

Honeywell International is a diversified industrial company. The company has four divisions: Aerospace, Honeywell Building Technologies, Performance Materials & Technologies and Safety & Productivity Solutions. Honeywell International has more than 130,000 employees around the world and more than 40% of sales come from international markets. The company generates \$32 billion in annual revenues. Honeywell International completed its spin-off of its Transportation Systems unit, called Garret Motion, on 10/1/2018. The company then spun off its Homes & Global Distribution business, called Resideo Technologies, on 10/29/2018.

Honeywell International reported first quarter earnings results on 5/1/2020. The company's earnings-per-share increased 15% to \$2.21, beating estimates by \$0.27. Revenue declined 4.7% to \$8.5 billion, missing estimates by \$92 million. Organic sales decreased 4%, though segment operating margins expanded 140 basis points.

With 1% organic growth, Aerospace was the lone segment to grow during the quarter. Margins improved 280 basis points to 27.9%. U.S. defense and space were strong, as was air transport aftermarket demand. Safety & Productivity Solutions organic sales declined 9% with margins dropping 90 basis points to 12.5%. Although demand for personal protection equipment was robust due to the COVID-19 pandemic, gas sensing and retail were extremely weak. This quarter was also a tough comparison to Q1 2019 for the Intelligrated business. Sales for Honeywell Building Technologies was lower by 6%, but margins improved 100 basis points to 20.5%. Commercial fire orders were higher than expected, but were more than offset by lower volumes in security and building management products. Building Solutions were weak in the Americas and China regions. Performance Materials & Technologies declined 5% with margins dropping 50 basis points to 21.4%. This segment was hurt once again by illegal imports of hydrofluorocarbons into the European Union after the EU reduced its supply by nearly 40% in 2018. Also impacting results was weak demand for Process Solutions. Honeywell International repurchased \$1.9 billion of stock during the quarter.

Honeywell International has pulled its guidance for 2020 due to the uncertainty regarding the impact of the COVID-19 impact on results. The company does expect the second quarter to have significant declines in all segments, most pronounced in Aerospace, which is likely to be down more than 25% year-over-year. This segment will face headwinds due to weak demand for commercial aviation. Consensus estimates call for earnings-per-share of \$7.33 for the year.

While Honeywell International did see earnings decline 24% during the last recession, the company has managed to grow earnings every year since 2010. While the short term will be challenging for the company, we expect earnings growth to accelerate following a recovery from the COVID-19 pandemic. Therefore, we are increasing our expected

growth rate through 2025 to 9% from 7% due to a combination of organic growth, margin expansion and share repurchases.

Honeywell International has paused, but not cut, its dividend growth several times over the past two decades, most recently in 2010. The company increased its dividend 9.8% for the 12/6/2019. This is the tenth 10%+ increase since 2010. In order to be conservative, we forecast that dividend will grow in line with earnings going forward.

Honeywell International shares have decreased \$37, or 21.4%, since our 2/2/2020 report. Factoring in revised earnings-per-share estimates for 2020, shares have a forward multiple of 18.6. We reaffirm our target price-to-earnings multiple of 16 for the stock, slightly above the 10-year average multiple of 15.6. If shares reverted to our target multiple by 2025, total returns could be reduced 2.9% per year over this time frame.

Safety, Quality, Competitive Advantage, & Recession Resiliency

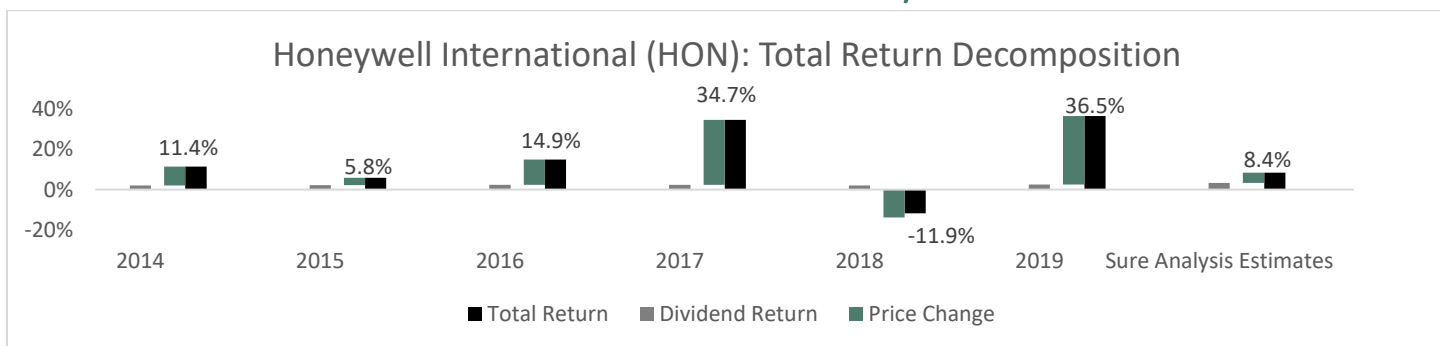

Industrial companies tend to perform very well when the economy is strong, but struggle in weak economic climates. As with most industrial companies, Honeywell International is seeing earnings decline in this recession. Honeywell International divested two lower margin businesses in the form of spin offs last October. This should allow the company to focus on its higher margin businesses, particularly in Aerospace. Commercial and military products remain in high demand. With higher sales for this division, aftermarket services should see growth as well. As long as the economy remains strong, the company's other products, such as Intelligrated and industrial products like Solstice, should perform well. We see Honeywell's strong position in these markets as its competitive advantage.

Final Thoughts & Recommendation

Following first quarter results, Honeywell International is now projected to return 8.4% annually through 2025, up from our previous estimate of 4.9%. Results for the quarter were mixed as earnings improved while revenue declined from the previous year. Honeywell International is likely to struggle during the pandemic as its products are expected to see slowing demand. That said, we expect demand to return once a recovery takes place. We maintain our hold rating on the stock, but income investors may find the yield, which is above the market average, more attractive as shares decline. We have lowered our 2025 price target \$17 to \$180 due to lowered EPS expectations for 2020.
