Overview & Current Events

ABB is a global provider of automation technologies and power solutions. The company operates in more than 100 countries and has four business units: Electrification Products, Robotics & Discrete Automation, Motion and Industrial Automation. ABB is incorporated in Switzerland, but domestic investors can initiate an ownership stake in the company through American Depositary Receipts that trade with a market capitalization of US\$51.5 billion under the ticker ABB on the New York Stock Exchange.

On July 1st, 2020, ABB sold 80.1% of its Power Grids business to Hitachi for net cash proceeds of about \$7.7 billion. ABB will use the proceeds to repurchase up to 180 million shares while it will also strengthen its balance sheet.

In late October, ABB reported (10/23/20) financial results for the third quarter of fiscal 2020. The pandemic continued to take its toll on the results of the company. Comparable revenue and orders fell -4% and -8%, respectively, and operational earnings-per-share decreased -36%. ABB had previously guided for improved performance in the second half of the year, partly thanks to the recovery of China from the pandemic, but its Robotics and Industrial Automation segments need more time to recover. As a result, management now expects a sequential decrease in revenue in the fourth quarter. We have thus lowered our earnings-per-share forecast for the year from \$1.16 to \$1.00.

ABB's per-share growth in net income over the last decade has been far from compelling. Even worse, the company is now facing a fierce pandemic, which has caused a global recession. However, we expect the global economy to begin to recover from next year. Moreover, ABB has a number of current growth opportunities that lead us to believe its future performance will be stronger than its historical track record. The Electrification segment, which generates 46% of the total revenues of ABB, seems to have the most promising prospects thanks to strong demand in key segments, such as rail, data centers, wind and electric vehicle infrastructure. We expect 8% average annual growth of earnings-per-share off this year's low comparison base over the next five years.

ABB has traded at an average price-to-earnings ratio of 19.2 over the last decade. With that said, this sample includes several years (2014-2017) in which the stock traded with an elevated P/E ratio. We believe that fair value for a company of ABB's caliber lies somewhere around 16 times earnings. The stock is currently trading at a decade-high price-to-earnings ratio of 24.0. If the stock trades at our estimated fair earnings multiple of 16.0 in five years from now, it will incur a -7.8% annualized drag in its returns.

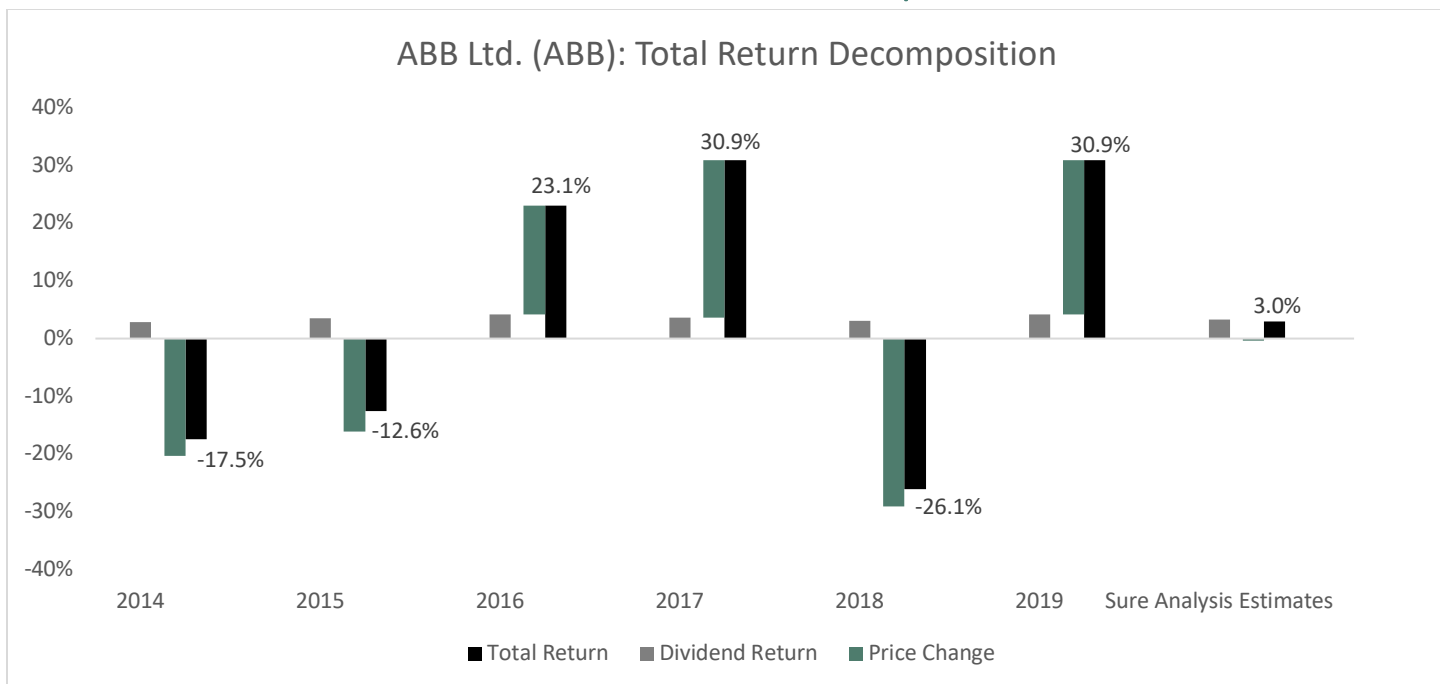
ABB has global businesses that are either the #1 or #2 player in attractive markets, with strong secular growth. The company expects its business markets to grow by 3.5%-4.0% per year on average over the long run. Thanks to its dominant position in its segments, ABB has a strong reputation and thus enjoys a significant competitive advantage over its peers.

Moreover, the company has a strong balance sheet, with its interest expense having consumed only 9% of its operating income in the last 12 months. On the other hand, the performance of ABB is greatly affected by economic growth and oil prices, which are beyond its control. Due to this vulnerability, the stock tends to underperform the market during sell-offs. Consequently, only investors who can tolerate significant price pressure should consider this stock.

Final Thoughts & Recommendation

ABB has a variety of appealing characteristics. It is a global business with leadership in many segments of the industrial sector. Moreover, we view the global recession as temporary and expect the business of ABB to begin to recover from next year. However, the stock of ABB has rallied 50% off its bottom and thus it is now trading at a decade-high price-to-earnings ratio. It will also be highly vulnerable if the pandemic lasts longer than currently anticipated. Overall, we expect the stock to offer low returns over the next five years. We thus rate the stock as a sell.
