Stock Market News

- [Royal Caribbean \(RCL\) purchases remaining 1/3 shares of Silversea Cruises from Heritage Cruise Holdings](#). Royal Caribbean had purchased 2/3 of Silversea Cruises back in 2018.
- [Sony \(SNE\) buys a minority stake in Fortnite maker Epic Games for \\$250 million](#).

- **Barrick Gold (GOLD)** serves a dispute notice to the Papa New Guinea government after the company's Porgera mine lease was not extended.
- The Trump administration issues a petition for the U.S. district court in Michigan to reject a settlement between **DTE Energy (DTE)** and the Sierra Club. The settlement required DTE Energy to shut down 3 coal power plants and pay \$2 million for local environment improvements, plus a \$7.3 million settlement with the federal government.
- **Brown & Brown (BRO)** acquires substantially all the assets of First Resource, a finance and insurance provider to auto dealers.
