Overview & Current Events

Johnson Controls, originally founded in 1885, is a \$38 billion industrial company that offers Building Solutions (cooling, heating, ventilation, and security) around the world, with roughly 40% of its sales coming from North America. Johnson Controls is headquartered in Ireland after its merger with Tyco in 2016. In November of 2018 the company announced it was selling its Power Solutions business. The Power segment made up about a fourth of Johnson Control's business and this sale now makes the company a "pure play" buildings technologies and solutions provider. On April 30th, 2019, Johnson Controls completed the sale of its Power Business for \$11.6 billion in net proceeds. The company then launched an equity tender of 102 million shares for \$4.0 billion and repaid \$3.4 billion of debt.

On August 4th, 2022, Johnson Controls reported Q3 fiscal year 2022 results for the period ending June 30th, 2022.

(Johnson Controls' fiscal year ends September 30th.) For the quarter, sales came in at \$6.6 billion, a 4% gain compared to Q3 2021. The Building Solutions North America and Global Products segments saw a 10% and 6% gain, while the Building Solutions EMEA/LA and Building Solutions Asia Pacific segments posting declines of 5% and 5%, respectively. Adjusted net income equaled \$0.85 per share, a 3% increase compared to \$0.83 per share in Q3 2021. The company ended the quarter with a backlog of \$11.1 billion, up 13% year-over-year.

Johnson Controls also introduced Q4 guidance, anticipating \$0.96 to \$1.00 in adjusted earnings-per-share, and narrowed full year 2022 guidance to \$2.98 to \$3.02 in adjusted earnings-per-share from previous expectations of \$2.95 to \$3.05.

The Johnson Controls of today looks very different from the Johnson Controls of five years ago due to the Tyco merger and automotive business spinoff, which is now publicly traded as Adient (ADNT). The 2016 merger with Tyco relocated Johnson Controls to Ireland for tax purposes. Yet tax legislation changes in the U.S. meant that the benefit of that move evaporated, and Johnson Controls was left with the integration costs of the merger.

Moreover, the complexity of looking back at historical numbers continues to evolve with the sale of the Power Business. We have kept the historical numbers through 2017, but we have inputted only earnings from continuing operations starting with 2018. We believe the Building Solutions segment ought to do well, but keep in mind that the business results could be increasingly volatile, as the company has become more and more concentrated.

We are forecasting \$3.00 in EPS for 2022 – the midpoint of current guidance - and 6% growth.

Looking at the 2012 through 2021 period, shares of Johnson Controls have traded hands with an average P/E ratio of about 15 times earnings. Earnings-per-share were temporarily depressed after the sale of the Power Business, but they have since rebounded due in large part to Johnson Controls retiring a significant amount of stock. We are using 16 times earnings as a starting fair value baseline, taking into account the ongoing growth avenues – both organically and via share repurchases. With shares trading at 18.1 times the midpoint of guidance this implies a valuation headwind.

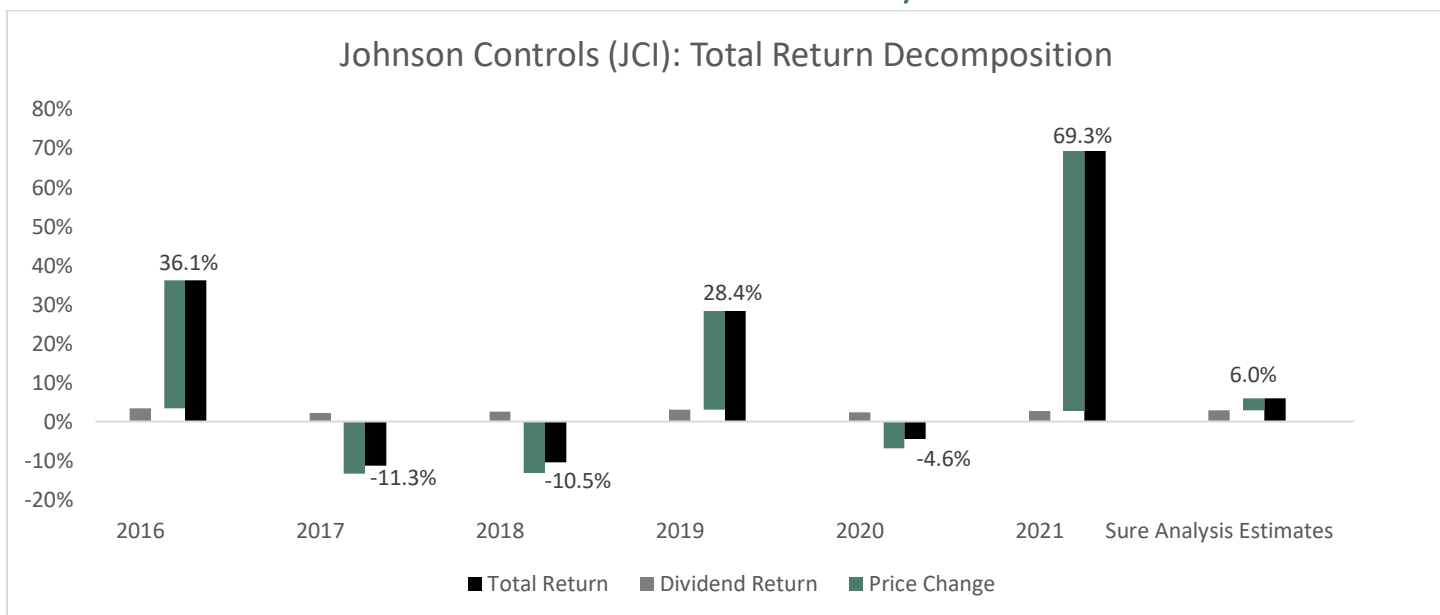
Johnson Controls is one of the key players in the building construction industry, where it provides products and services for heating, ventilation, cooling, and security systems. The company's sales network and expertise are hard to replicate for new entrants. Moreover, the sale of the Power business has led to financial flexibility, an increased focus on growth trends, lower capital intensity, and margin expansion.

As of Q3 2022, Johnson Controls held \$1.5 billion in cash, \$11.6 billion in current assets and \$42.3 billion in total assets against \$11.9 billion in current liabilities and \$26.3 billion in total liabilities. Long-term debt stood at \$7.2 billion.

Final Thoughts & Recommendation

Shares are down 32% year-to-date, which compares unfavorably to the broader market. Johnson Controls' business continues to transform, with the newest iteration being a "pure play" Buildings Solution company. It should be noted that this transformation comes with added uncertainty in the way of a less diversified business. We are forecasting 6.0% annual total return potential, driven by 6% growth and a 2.5% starting dividend yield offset by the potential for a valuation headwind. Shares earn a hold rating.
