Overview & Current Events

AptarGroup Inc. (ATR) began trading as an independent company in 1993 and is now one of the leading businesses in the global dispensing systems industry. With a market capitalization of approximately \$7.64 billion, The company has over 14,000 employees in 18 countries and produced \$3.32 billion in revenue in 2022. The company is divided into three business segments: "Beauty + Home," "Food + Beverage," and "Pharma."

The company reported fourth-quarter and full year results for Fiscal Year (FY)2022 on February 16, 2023. Sales decreased (2)% for the quarter compared to the fourth quarter of 2021. Sales in 4Q2021 were \$813.9 million, while sales in 4Q2022 were \$795.9 million. Core sales increased 4% and adjusted EBITDA of \$147 million decreased (4)% from the prior year. Core sales growth in the quarter was driven by strong volume growth in pharma and beauty, as well as price increases in the Beauty + Home segment. Aptar's Pharma segment achieved double-digit core sales growth due to increased volumes across each end market. The Pharma segment saw increase 6% year-over-year. Sales growth driven primarily by significant demand from the prescription, consumer healthcare and active material markets. Aptar's Beauty + Home segment continued to benefit from pricing initiatives and increased demand for prestige fragrance, sunscreen and hair care applications as a result of increased mobility and travel. On a per-share basis, the company reported \$0.89 per share compared to \$0.85 during the same period a year ago, increasing by 4.7% for the fourth quarter.

The company expects EPS for the full year of FY2023 to be \$4.00. This will be an increase of 5.5% compared to FY2022.

AptarGroup has grown organically and via occasional acquisitions. In 2018, the company spent \$528 million on acquisitions, which is its most substantial amount spent on investments in recent history and should contribute to significant growth in the coming years. When acquisitions are not notable, the company historically uses cash or debt to repurchase shares and averages a -0.2% share reduction per year. However, in recent years, total shares have been increasing per year. The Pharma segment is AptarGroup's most profitable segment, as it accounts for approximately one-third of company sales but two-thirds of its EBITDA. The company's Pharma segment is its primary growth driver, although currency impacts and tax changes are currently acting as headwinds. We estimate 7.0% annual earnings and a 4.0% dividend growth over the next five years. The dividend growth has slowed down as the company has a 10-year dividend growth average of 6.1%, and the five-year dividend CAGR is 3.5%.

AptarGroup currently trades for a valuation of over 26.5 times earnings, which we consider rich for a company with low growth. The security looks fairly valued compared to its 10-year average of 27.3 times earnings. Additionally, the dividend yield is lower with its ten-year average of 1.5%.

From this point, there is more potential for a valuation reduction rather than valuation expansion over the next five years, in our view. We believe that a valuation of 20x earnings, modestly below its 10-year average, is fair given the company's adequate expected growth potential.

AptarGroup has over 5,000 customers, with no customer accounting for more than 6% of sales. Additionally, three-quarters of sales come from outside the United States, with more than half of Europe's sales. The company has various patents and trademarks to protect its designs. However, it faces stiff competition and has historically achieved returns on invested capital marginally higher than its weighted average capital cost. However, the Pharma segment enjoys high switching costs due to regulatory certification and has higher profit margins.

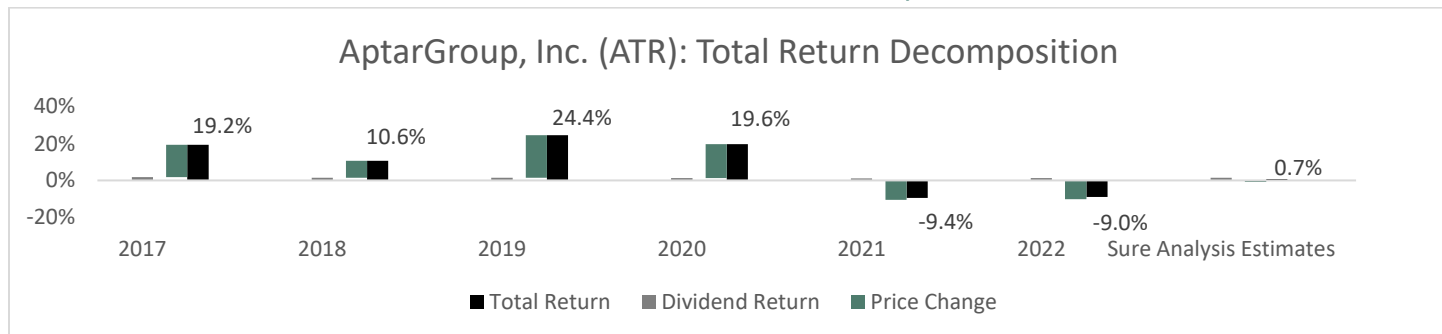
AptarGroup has paid growing dividends for 28 consecutive years and maintains a low payout ratio. The company was only mildly affected by the previous recession, as it remained profitable and quickly recovered to all-time high sales and earnings in 2010. Its products across all three business segments are not very cyclical.

The company has nearly doubled its long-term debt over the past four years, but its interest coverage ratio remains healthy at over 9.9x. Also, the company has a debt-to-equity ratio of 0.7x which is really good. AptarGroup makes substantial use of leverage, although its consistent earnings should allow it to support that leverage safely.

Final Thoughts & Recommendation

In our view, AptarGroup is a durable company with a long history of growing dividends. However, the valuation is higher than its historical average and what we consider fair for this growth level. The company's sizeable foreign exposure is both a source of opportunity and a risk. We rate AptarGroup as a sell now due to its low expected total returns of just 0.7% per year for the next five years.
