Overview & Current Events

Microchip Technology develops, manufactures, and sells smart, connected and secure embedded control solutions used for a wide variety of applications. These include disruptive growth trends such as 5G, artificial intelligence, Internet of Things (IoT), and autonomous driving, amongst others, in key end markets such as automotive, aerospace and defense, communications. The company's strategic focus is that these solutions are cost-effective, offer high performance, with a wide voltage range operation, at extremely low power usage. Microchip Technology generates around \$6 billion in annual revenues and is based in Chandler, Arizona.

On May 6th, 2024, Microchip Technology raised its dividend by 0.4% to a quarterly rate of \$0.452. On a year-over-year basis, the dividend grew by 18%. It marked the 59th consecutive sequential increase.

On the same day, Microchip Technology also posted its Q4 and full-year results for the quarter ending March 31st, 2024. For the quarter, net sales were \$1.33 billion, down 40.6% from the comparable period last year.

Lower revenues were driven by weaker business conditions following several consecutive periods of record growth. Due to lower production, GAAP gross margins fell from 68% last year to 59.6%. This fall in sales and compression in margins led to a net income of just \$154.7 million, or \$0.28 per diluted share, down from \$604.0 million, or \$1.09 per share, last year. On a non-GAAP basis, EPS was \$0.57 versus \$1.64 in Q4-2023. For FY2024, GAAP EPS came in at \$3.52, while non-GAAP EPS per diluted share came in at \$4.92.

Non-GAAP results are more meaningful in understanding Microchip's operating performance as it excludes its high share-based compensation, manufacturing excursion, high depreciation & amortization, and other factors. We use non-GAAP figures to accurately value the stock and assess its future returns, but all other figures in the table are GAAP-based, as officially shown in the company's filings with the SEC.

We expect the ongoing weakness to persist as the company's as customers and channel partners continued to reduce inventory. Thus, we project non-GAAP EPS of \$2.63 for FY2025.

Microchip Technology's EPS has struggled to improve meaningfully over the past decade despite the company growing its revenues relatively consistently. This has been mostly due to higher operating and R&D expenses, as well as increased financial expenses. However, with management's goal to expand margins while taking advantage of the ongoing sky-high demand for chips, non-GAAP EPS started to snowball post-pandemic. While weakness in the industry is likely to pressure EPS this year, we expect growth of 15% over the medium-term, which reflects the possibility of a rebound in demand for the company's chips. In terms of its dividend, Microchip has hiked it 81 times (including a track record of 59 consecutive sequential hikes) over the past 22 years. These quarter-over-quarter increases were quite marginal in some

cases (look at 2014 to 2021 for example). That said, we forecast DPS growth of 15% moving forward to reflect the recent DPS growth acceleration and management's goal of returning 100% of Microchip's adjusted free cash flow to shareholders by FQ4 2025.

Valuation Analysis

Microchip currently trades at a P/E of 35X based on our expected FY2024 non-GAAP EPS estimates. This multiple reflects the market's expectation for a strong rebound in earnings growth from FY2026 onwards. Nevertheless, this multiple also implies a natural valuation headwind from our fair multiple of 18X. The yield remains modest, but we expect it to rise following future dividend hikes.

Safety, Quality, Competitive Advantage, & Recession Resiliency

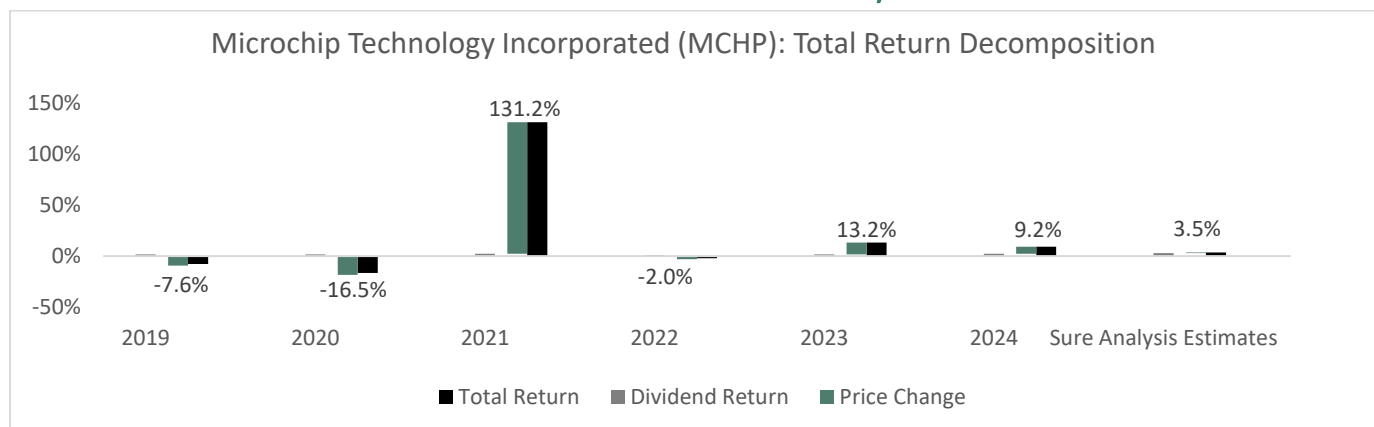

Microchip's dividend should be quite safe, being covered multiple times by operating cash flows. The normalized payout ratio seems high only due to the company's GAAP results, which carry heavy stock-based compensation expenses and depreciation & amortization (a non-cash item). The company enjoys several qualities and positive catalysts, including a robust backlog that should provide stable and predictable cash flows moving forward, expanding margins, and a declining long-term debt position (currently \$5.00 billion vs. \$9.55 billion in 2019). Still, the company faces several noteworthy risks, including fierce competition, global industrial cyclicality effects, limited visibility to product shipments, and international risks such as FX fluctuations due to its global clientele. A global recession could adversely impact the company's results, though global demand for chips remains far ahead of supply capabilities, at least for now.

Final Thoughts & Recommendation

Microchip Technologies has rallied massively over the past decade, with the company's sales expanding during this time as a result of the increased demand for chips. Despite a weak Q4 recently, the company should continue to grow EPS at a rapid pace from FY2026 onwards. Additionally, management is committed to growing the dividend sequentially, which should add to total returns. Nevertheless, due to the possibility for a heavy multiple contraction, we estimate annualized returns of just 3.5% through fiscal year 2030. Shares earn a sell rating.
