Overview & Current Events

City Holding Company (CHCO) serves as the holding entity for City National Bank of West Virginia, offering a comprehensive range of financial services throughout the United States. These services encompass banking, trust, and investment management, with a diverse suite of products, including checking, savings, money market accounts, certificates of deposit, and individual retirement accounts. The company's portfolio encompasses commercial and industrial loans, commercial real estate loans, residential real estate loans, home equity loans, and consumer loans. Additionally, they provide mortgage banking services and a variety of deposit and wealth management solutions for individual and commercial clients, along with modern banking technologies such as ATMs, interactive teller machines, mobile banking, and credit and debit card services.

On October 24th, 2024, the company announced results for the third quarter of 2024. City Holding reported net income of \$29.8 million, translating to \$2.02 per diluted share, which beat estimates by \$0.10. The company achieved impressive returns with a 1.87% ROA and a 20.9% return on tangible equity. Net interest income rose 1.8% from the previous quarter to \$55.6 million, driven primarily by an increase in loan yields and outstanding loan balances, despite higher costs for interest-bearing liabilities. CHCO maintained a steady net interest margin of 3.87% during the quarter, underpinned by growth in investment balances and steady loan demand.

In credit quality, CHCO saw an uptick in nonperforming assets, with the ratio to total loans rising to 0.39%. Notably, a \$2.0 million charge-off was recorded for a distressed commercial loan in the movie theater sector, impacted by operational challenges post-COVID. Nevertheless, CHCO maintained resilience with strong asset quality and provisioned \$1.2 million for credit losses. Non-interest income showed solid growth, up by 10.3% year-over-year to \$20.3 million, with notable contributions from life insurance proceeds and trust fees. With an increase in non-interest expenses to \$37.6 million, CHCO remains focused on growth, as reflected in a quarterly dividend increase of 10% to \$0.79 per share. The company's capital ratios stayed robust, significantly above regulatory requirements, reinforcing its strong capital position to support ongoing strategic initiatives.

City Holding's performance reflects its focus on stability and growth, which are underpinned by its core values. With consistent non-performing asset ratios and a robust risk management strategy, the company's proactive approach to maintaining credit quality is evident. The growth of loans, notably in commercial and industrial sectors, demonstrates their value in supporting local businesses and economic development. However, the dip in commercial real estate loans suggests cautious lending practices. An increase in average depository balances mitigates the decline in period-end

deposit balances, thanks to acquisitions from Citizens. Nevertheless, a decline in savings and non-interest-bearing demand deposits, counterbalanced by growth in interest-bearing demand and time balances, shows a shift in customer deposit preferences. In line with the analysts' estimates and the favorable microenvironment, we expect the company to post an EPS of \$7.82 in 2024. We estimate an EPS growth of 10.0% over the next five years, leading to our estimated EPS of \$12.59 by 2029. Moreover, the company has a solid record of paying dividends despite operating in a macroeconomically sensitive sector, as City Holding has paid an increasing dividend for the past six years. We expect the company to maintain its dividend growth and have forecasted a dividend CAGR of 5.0%, leading to a dividend of \$4.03 by 2029.

The regional bank trades at a forward P/E of 15.0, higher than the long-term average P/E of 14.1 and the five-year average P/E of 13.0. Even though the higher interest rates and an uptick in the loan portfolio will benefit the company in the near-term, we assign a P/E of 10.0 to the stock, which is a fair reflection of its value in our view, leading to our target price of \$126 by 2029.

Safety, Quality, Competitive Advantage, & Recession Resiliency

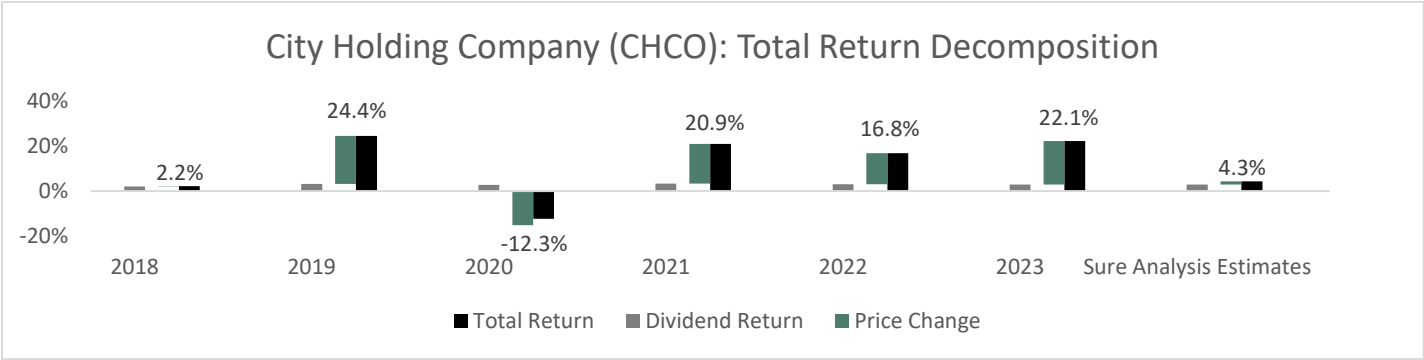

The company has paid a consistent dividend to its shareholders with a 10-year payout ratio averaging 44%, and we expect the company to maintain and increase its payout in the future. The demand for loans has recovered in recent quarters, and we expect the company to be in a much better position in the future than it is today. In addition, the margins continue to improve in the high-interest rate environment, and the net interest margin ought to be high, driven by the Fed's 'higher for longer' stance. City Holding Company repurchased 36,000 shares at an average price of \$100.24 in Q3 2024, as part of its 1,000,000-share buyback program authorized earlier this year.

Final Thoughts & Recommendation

While City Holding runs an interest rate-sensitive regional banking business, increased loans and net interest margins will be a positive catalyst for EPS growth. Indeed, City Holding's dividend growth prospects could remain strong throughout the medium-term. However, we maintain our hold rating for CHCO premised upon the 4.3% annualized total returns for the medium-term, derived from the forecasted earnings-per-share growth of 10.0%, the 2.7% dividend yield, and a valuation headwind.
