Overview & Current Events

Colony Bankcorp (CBAN) is the holding company of Colony Bank, the largest community bank in Georgia, which was founded in 1975 and is headquartered in Fitzgerald, Georgia. It operates 34 branches in Georgia, 1 branch in Alabama and 1 branch in Florida and provides various banking products and services to commercial customers and consumers. Commercial real estate loans comprise 55% of total loans while commercial, financial and agricultural loans comprise 31% of total loans. Colony Bankcorp has total assets of \$3.1 billion and a market capitalization of \$287 million.

In late July, Colony Bankcorp reported (7/23/25) financial results for the second quarter of fiscal 2025. Loans grew 4% while deposits decreased -2% over the previous quarter. Net interest margin expanded from 2.93% to 3.12% thanks to lower deposit costs. As a result, net interest income grew 7%. Moreover, noninterest income grew 11% and provisions for credit losses decreased sharply. As a result, earnings-per-share surged 21%, from \$0.38 to \$0.46, beating the analysts' consensus by \$0.05. Notably, Colony Bankcorp has a much lower net interest margin than the average regional bank, mostly due to its focus on commercial customers. On the other hand, as the Fed reduced interest rates late last year, the net interest margin of the bank has begun to recover. Thanks to the positive momentum of the bank, we have raised our forecast for earnings-per-share this year from \$1.55 to \$1.75.

Colony Bankcorp has grown its earnings-per-share by 8.3% per year on average over the last decade but with significant volatility. It has also grown its earnings-per-share by 5.4% per year on average over the last five years. In the long run, the bank aims to grow its customer base by 8%-12% per year, both organically and via acquisitions, and benefit from economies of scale. In addition, the Fed cut interest rates last year and expects to reduce them further in the upcoming years. As a result, Colony Bankcorp is likely to see its net interest margin expand in the upcoming years. Given the high comparison base formed by the record earnings-per-share expected this year and the choppy performance record of this bank, we expect 3.0% average annual growth of earnings-per-share over the next five years, below the 5-year average of the company.

Colony Bankcorp has traded at an average price-to-earnings ratio of 11.6 over the last decade. We assume this valuation level as fair for this stock. The stock is currently trading at a price-to-earnings ratio of 9.7, which is lower than the

historical average of the bank. If the stock trades at its average valuation level in five years, it will enjoy a 3.6% annualized valuation gain.

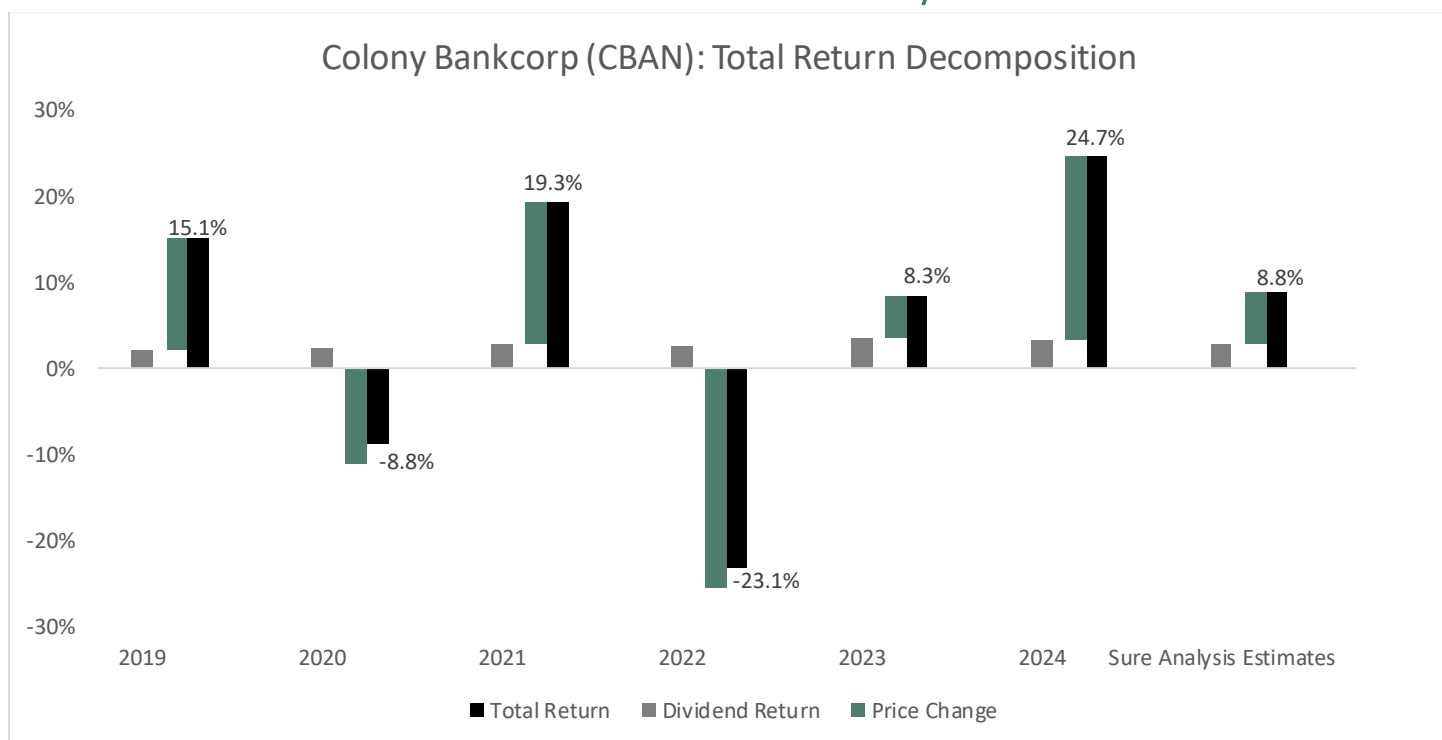
Colony Bankcorp has raised its dividend by 2% this year and thus it has now raised its dividend for 9 consecutive years. The bank is currently offering a dividend yield of 2.7%, which is lackluster and lower than the 3.1% median dividend yield of the financial sector. The bank has a healthy payout ratio of 26% and hence it can continue raising its dividend in the upcoming years. On the other hand, Colony Bankcorp has grown its dividend by only 2% per year on average over the last three years. Overall, the dividend appears safe in the absence of a severe downturn but yield and growth are modest.

Colony Bankcorp has a healthy Tier 1 Capital Ratio of 13.4% but it has exhibited a somewhat volatile performance record and has proved vulnerable to recessions and downturns of the financial sector. It incurred a -20% decrease in its earnings-per-share in 2019 and a -23% decrease in its bottom line in 2022 due to the surge of inflation and interest rates. Overall, the stock is suitable only for investors who can tolerate stock price volatility during downturns.

Final Thoughts & Recommendation

Colony Bankcorp has rallied 70% in less than two years thanks to the moderation of inflation and expectations for lower interest rates in the upcoming years. Despite its steep rally, the stock remains reasonably valued and can offer an 8.8% average annual return over the next five years thanks to 3.0% growth of earnings-per-share, its 2.7% dividend and a 3.6% valuation tailwind. The stock maintains its hold rating but investors should be aware of the risks related to the small market cap of the bank and its somewhat volatile business performance.
