Overview & Current Events

WesBanco is a diversified financial services company which offers retail banking, corporate banking, personal and corporate trust services, brokerage services, mortgage banking and insurance. It reports results through two segments, community banking and investment services. The bank, which was founded in 1870, operates primarily in the Rust Belt region of the United States. It is headquartered in Wheeling, West Virginia and currently trades with a market capitalization of \$3.3 billion. As of March 31st, 2026, the company had approximately \$27.5 billion total assets, and \$7.8 billion of assets under management.

On February 28th, 2025, WesBanco completed its acquisition of Premier Financial Corporation (PFC). Premier shareholders now own approximately 30% of WesBanco after the merger. The combined company became the 8th largest bank in Ohio, serving customers in nine states through over 250 financial centers, and has \$27 billion in assets.

WesBanco reported first quarter 2026 results on April 21st, 2026. Net income for the quarter, after adjustments for tax-restructuring and merger-related expenses, was \$87.3 million, a 71% increase compared to the same quarter of 2025. Earnings-per-share for the quarter increased by 38% to \$0.91.

Total portfolio loans increased 2.2% year-over-year to \$19.1 billion. Meanwhile, total deposits rose 1.8% year-over-year to \$21.7 billion due to organic growth.

The company achieved a net interest margin of 3.57% for the fourth quarter, which was up 22 basis point year-over-year due to higher earning asset yields and lower funding costs. Net interest income increased 36% year-over-year to \$215 million due to the impact of the PFC acquisition, loan growth and higher securities yields, and lower deposit and borrowing costs.

Adjusted results for the quarter produced an annualized return on average assets and average tangible common equity of 1.29% and 17.37%, respectively. Tangible book value per share rose 12% compared to last year to \$22.45.

The company closed 27 locations across its legacy markets on January 23rd, 2026, which is expected to generate net pre-tax savings of roughly \$6 million annually. It plans to close another ten locations in May.

The bank has grown historically through both organic growth and acquisitions. The majority of net revenues come from net interest income. Although earnings have grown relatively steadily over the long-term, recent results of WSBC have made this image hazier. Earnings dipped significantly in 2020 as a result of the COVID-19 pandemic, rebounded greatly in 2021, and declined every year until 2025. For 2026, we forecast earnings-per-share to come in at \$3.59, and for EPS to

grow by 7% through 2031. The merger with Premier Financial Corp., which has increased the company's total assets, and expanded its scale and reach, has strengthened WesBanco's growth prospects.

The company will continue to achieve earnings growth through loan growth, net interest margin expansion, and acquisitions. WesBanco is also aiming to diversify its revenue streams with new fee-based services to drive non-interest income growth.

The dividend has grown by 4.9% and 2.9% on average in the past nine and five years, and we forecast that a 4% dividend growth rate going forward is reasonable. Although the company has an authorized share repurchase program, the last decade shows that share count has trended upward, especially following the recent PFC acquisition.

Over the last ten and five years, WSBC has traded at an average P/E ratio of 12.6 and 10.9, respectively. While shares of WesBanco trade at 9.6 times forecasted earnings today, we peg fair value at 10.9 times earnings, which implies a moderate valuation tailwind.

We expect WSBC to continue increasing the annual dividend while keeping it within a safe payout ratio around the halfway mark on a normalized basis. The current 4.4% yield is slightly above the company's 5-year average yield of 4.4%.

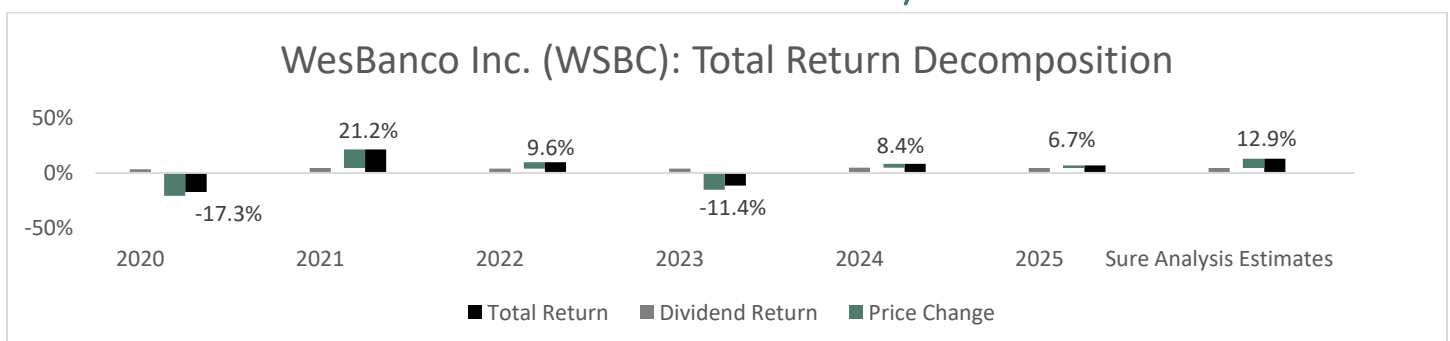
The payout ratio has historically been fairly safe, and 2020 was an outlier due to the pandemic with a heightened payout ratio, but still, the dividend was well covered during the year. However, amidst the great financial crisis, the corporation cut its dividend in half in 2009. The bank is not recession resistant, and this could be a cause for concern that the dividend may be cut again in the future. Still, it has increased its dividend for the past twelve years. Sadly, it took until 2017 to regain and surpass the dividend which was slashed in 2009.

The bank does not have a particularly strong competitive advantage over its peers as it operates and competes in the same way other small banks do. The corporation has a diversified earnings stream, which is led by its century-old trust and wealth management business and has a strong presence in economically diverse and major markets which are supported by positive demographic trends.

Final Thoughts & Recommendation

The share price of WSBC has increased by 16% over the last year, well below the S&P 500 Index's 31% gain. WSBC can still offer 12.9% annual total returns stemming from 7.0% EPS growth, the 4.4% yield, and 2.5% P/E multiple expansion. WesBanco earns a hold rating.
