Overview & Current Events

Home Depot was founded in 1978 and since that time has grown into a juggernaut home improvement retailer with over 2,300 stores in the U.S., Canada and Mexico that generate around \$165 billion in annual revenue. The stock has a market value of \$312 billion, making it one of the larger companies by market capitalization in the United States. It trades under the ticker symbol HD on the NYSE.

On June 18th, 2024, Home Depot completed its acquisition of SRS Distribution, a leading residential specialty trade distribution company, for an enterprise value of \$18.25 billion. This acquisition expanded Home Depot's total addressable market by \$50 billion to \$1 trillion.

On September 4th, 2025, the company completed its acquisition of GMS Inc., a specialty building products distributor, for \$110 per share, for a total enterprise value of roughly \$5.5 billion. GMS merged into SRS, creating a network of over 1,200 locations and a fleet of over 8,000 trucks which could make 10,000+ jobsite deliveries per day.

On May 11th, 2026, Home Depot's subsidiary SRS acquired Mingledorff's, LLC, a leading HVAC distributor with 42 locations in five southeastern U.S. states. The acquisition expanded HD's total addressable market to \$1.2 trillion.

On February 24th, 2026, Home Depot announced a 1.3% increase to the dividend to \$9.32 per share annualized.

Home Depot reported first quarter 2026 results on May 19th, 2026. The company posted sales of \$41.8 billion, a 4.8% increase from the previous year. Comparable sales in the quarter rose 0.6%. Net earnings equaled \$3.3 billion, or \$3.30 per share, compared to \$3.4 billion, or \$3.45 per share in Q1 2025. Adjusted EPS was \$3.43, down 3.7% from Q1 25.

The average ticket price rose by 2.3% over last year, increasing from \$90.71 to \$92.76. However, the number of customer transactions fell 0.9% to 391.1 million.

As of the end of 1Q26, Home Depot had cash and cash equivalents amounting to \$1.601 billion.

Management reaffirmed its guidance for 2026, still expecting total sales growth of 2.5% to 4.5%, the addition of 15 new stores, and diluted EPS to increase by 0% to 4% from 2025.

Home Depot's earnings momentum has been enormous in the past decade as it has been able to fully capitalize on the housing and construction boom that ensued following the Great Recession. Then, in the depths of the COVID pandemic, business boomed as the demand for home remodeling and renovations surged. We see five-year annual earnings per share growth of 6.0%, consisting of comparable sales in the low single digits, a low single-digit tailwind from buybacks, a

potential low single-digit tailwind from operating margin improvements, and acquisitions. Average ticket sales increases will also continue to add to the top line.

On the share repurchase front, Home Depot spent nearly \$8.0 billion and \$6.7 billion in 2023 and 2022, respectively. In August 2023, the company approved a \$15 billion share repurchase program. However, in 2024, it only repurchased \$649 million of its stock, as it spent a significant sum on its acquisition of SRS. And in 2025, it did not repurchase any of its shares, but it acquired GMS Inc.

The company's streak of meaningful dividend growth should continue, however, given the recent low increases, we now see the payout rising at only half the pace of earnings, reaching \$10.80 per share in five years. Home Depot's 3.0% yield is above its historic average. The company still has room to continue raising the payout in the years to come.

The share price of Home Depot has come down recently, and the stock now trades below our estimate of fair value. Shares trade for 20.9 times our earnings estimate for this year, while we see fair value at 21.8 times earnings. As a result, we see the potential for a valuation tailwind.

Safety, Quality, Competitive Advantage, & Recession Resiliency

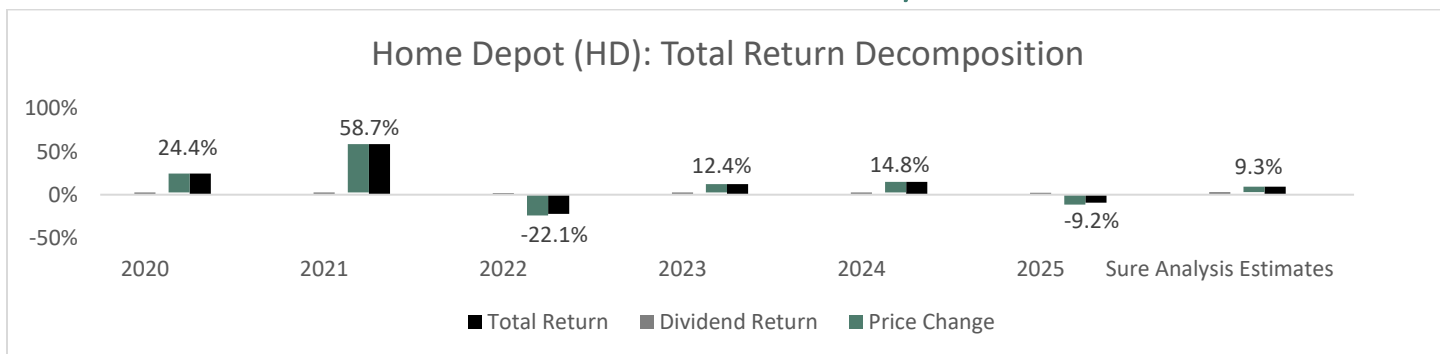

Home Depot's payout ratio is above half of earnings, and we expect it will remain in this range for the foreseeable future. Still, the dividend remains safe at this level, and it has room to grow in the future as earnings expand. Home Depot's competitive advantage is its enormous footprint, strong brand recognition and inventory variety. Supplanting its dominant position in home improvement will be extremely difficult for all comers, including rival Lowe's. The company is likely to suffer during a recession, but weakness would be a buying opportunity for long-term investors. With the coronavirus pandemic forcing many to stay home, home renovations is how many people spent their time, which was reflected in Home Depot's stock, seeing total returns of 24.4% in 2020 and 58.7% in 2021.

Final Thoughts & Recommendation

Home Depot offers investors the chance to own a stock that is dominant in its industry with stable long-term earnings and dividend growth outlooks. The share price of HD has decreased by 9% year-to-date, and it is now trading at 96% of our fair value estimate. We expect total annual returns of 9.3% going forward, consisting of the current 3.0% yield, 6.0% earnings-per-share growth, and 0.8% P/E multiple expansion. HD maintains its hold rating.
