Overview & Current Events

Clearway Energy Inc is a large electric utility company which owns and operates contracted energy generation across two segments: conventional generation, and renewables. The company possesses approximately 13,900 net MW of assets. Clearway is a large owner of renewable energy with 11,100 MW of installed wind, solar and energy storage projects. Approximately 2,800 net MW of the company's energy comes from dispatchable power generation. The power company trades on the NYSE under the ticker symbol CWEN. It is headquartered in Princeton, New Jersey.

Clearway Energy's controlling investor is Global Infrastructure Partners III (GIP), and Clearway Energy Group is the company's portfolio business from which they invest in infrastructure and businesses in OECD and certain emerging market countries. Clearway Energy Group owns or has an interest in more than 10 gigawatts of wind, solar and energy storage assets, and an ongoing development pipeline across the U.S. The group's large renewable power generation offsets over 10.5 million metric tons of carbon emissions.

On May 1st, 2022, the company completed the sale of its Thermal Business for net proceeds of roughly \$1.35 billion.

On August 7th, 2022, GIP completed a transaction resulting in TotalEnergies (NYSE: TTE) acquiring half of GIP's interest in Clearway Group. The benefit to Clearway is that TotalEnergies will provide Clearway with a right of first offer on its U.S. onshore renewable assets, and provide marketing and corporate relationships to aid in the commercial value of Clearway's development and operating projects.

On April 29, 2025, Clearway acquired Tuolumne Wind, a 137 MW wind project. Then on July 16, 2025, the company acquired Catalina Solar, a 109 MW solar facility in California for \$127 million. And on March 30, 2026, Clearway acquired a 613 MW operational solar portfolio from Cardinal (formerly Deriva Energy).

On February 17th, 2026, Clearway again raised its quarterly dividend by 2% to \$0.4676 per share, or \$1.87 per year.

Clearway Energy reported second quarter 2026 results on August 5th, 2026. The company generated \$409 million in adjusted EBITDA for the quarter, up 19% from \$343 million in the prior year quarter. Cash from operating activities rose 12% to \$214 million and cash available for distribution (CAFD) was \$167 million compared to \$152 million in Q2 2025.

Leadership reduced its fiscal 2026 guidance for CAFD, now expecting \$430M to \$470M. This equates to approximately \$3.72 per share of CAFD based on our estimated fiscal 2026 share count.

Clearway's relevant earnings and cash available for distribution data goes back to 2015, when the company was known as NRG Yield, Inc. Earnings have been lumpy historically, and the corporation opts to measure performance and payout

using cash available for distribution. CAFD per share has grown by 1.4% and 7.3% CAGR in the last nine and five years, respectively.

We believe that Clearway can grow CAFD by approximately 3.0% annually over the intermediate term. The Clearway Group will lead the corporation into significant growth opportunities as they have an approximately 32 GW development pipeline. Rate increases and further acquisitions of existing renewable energy projects will add to CAFD per share as well. We expect that outstanding shares will continue to increase, resulting in earnings and CAFD being spread across more shares, which will be a small headwind on a per-share basis.

Since earnings is not the primary metric in valuing Clearway Energy given its volatility, we are valuing the company based on its CAFD per share. Clearway's ten-year and five-year average price-to-CAFD ratios are 8.2 and 9.7, respectively. Today, shares trade at the high end of this range at 9.3 times estimated 2026 CAFD per share. We peg fair value at 10 times CAFD per share, which would result in a 1.5% annualized tailwind to total returns.

Safety, Quality, Competitive Advantage, & Recession Resiliency

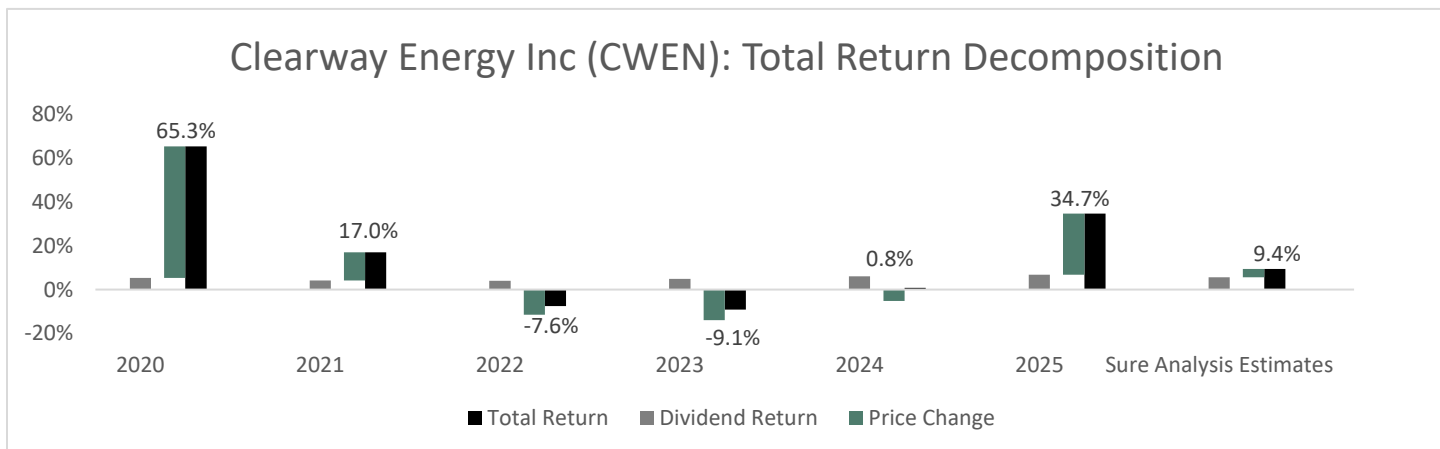

The company's payout has remained conservative on a CAFD per share basis; however, this includes one dividend cut in recent history. We don't have operating results dating back to the great financial crisis so we can't say with certainty how CWEN would have performed, but utility businesses are one of the safer industries during a recession. Results were not highly impacted by the COVID pandemic as power generation is essential. CWEN believes its knowledge and operating expertise to be its prime competitive advantage in the industry, as it allows it to make strong energy acquisitions, which it can utilize to grow CAFD.

Final Thoughts & Recommendation

Clearway Energy is backed by one of the largest infrastructure funds in the world, which gives it an advantage in accessing deals and building out its power portfolio, and the company has turned the corner on achieving meaningful growth. Clearway now trades at 93% of our estimate of fair value, and with forecasted annualized total returns of 9.4%, it receives a hold rating.
